

When you look at your scores, please remember that they are not really scores. They do not give you a relative value of the image, but are a summation of votes. The difference between(say) a 24 and an 18, or between 18 and 12, can be very small, when the Adjudicators are actuallyvoting Yes or No.

If you are heading for the next level bear in mind that even a score of 26 means that only 2 of the Adjudicators thought that it would be good enough at the next level.


